#### Procedure

The Centre Philosophy is an expression of the purpose, values and beliefs of the service. It states what the service aims to provide for the children and parents/guardians in the community. It is the foundation on which to build Centre goals, policies and procedures and will direct the focus of everything that happens in the Centre. The Centre Philosophy will be an important part of ongoing learning and reflective practice and will inform the centre setup of the Indoor and Outdoor Environments and daily routines (My Time, Our Place).

The Centre Philosophy will be reviewed annually as the centre undergoes review of the Quality Improvement Plan. The development and/or review of the Centre Philosophy requires input from key stakeholders including staff and Management.

The Philosophy will be used to inform the development of the Quality Improvement Program in line with Regulation 55.

#### Philosophy

At The Kids Castle, we believe that children are capable, competent & active learners.

We strive to support their growth and development by creating a safe and nurturing environment based on values and respect, where each child can participate in activities to enhance their individual development.

The Kids Castle provides a happy, stimulating, free-choice environment that is inviting, comfortable and inclusive of all children regardless of additional needs, diverse cultures or different beliefs. Our children are supported to engage freely in play experiences in a natural and creative way. They are also encouraged to initiate or contribute their ideas to the centre program.

The Kids Castle is a warm place where confidence is built, healthy forms of expression/ emotions are fostered and social skills are developed.

We aim to be supportive of all families and develop positive relationships between Staff, Children, Families, School and the wider Community.

Our aim is for children to:

- have a strong sense of identity
- be connected with and contribute to their world
- have a strong sense of wellbeing
- be effective communicators

The Program will:

- be varied and stimulating and focus on play and leisure activities
- involve the opinions of staff, children and parents to form the basis of the program
- provide opportunities for the children to use and develop social skills, explore and solve problems and engage in critical thinking.

• have a multicultural influence encouraging staff and children to be aware of their own world and develop positive attitudes towards cultural differences.

The staff will:

- provide a safe, secure and happy environment
- be sensitive to the uniqueness of each child
- take on continual learning and training
- develop a strong interpersonal bond between other staff, children and parents
- encourage, support and aid the children in their activities

The parents will:

- be encouraged to take an active role in the centre in sharing ideas and feedback.
- be encouraged to keep an open communication
